4. All nomination submissions **MUST** include
 - a. a letter from the nominee outlining their interest in the position, including any area of particular interest
 - b. a short biography (250 words maximum)
 - c. a .jpg format photo of the nominee. The photo is only used to confirm identity and for the CAPWHN website if the candidate is successful.

Nominations must be submitted by November 17, 2023 to Kimani Daniel, at kimani.daniel@mcgill.ca

The slate of directors will be proposed for ratification at the Virtual Annual General Meeting (AGM) on November 30th, 2023. In accordance with the Canada Not-for-Profit Corporations Act, individuals may also be nominated at the AGM Zoom meeting.
